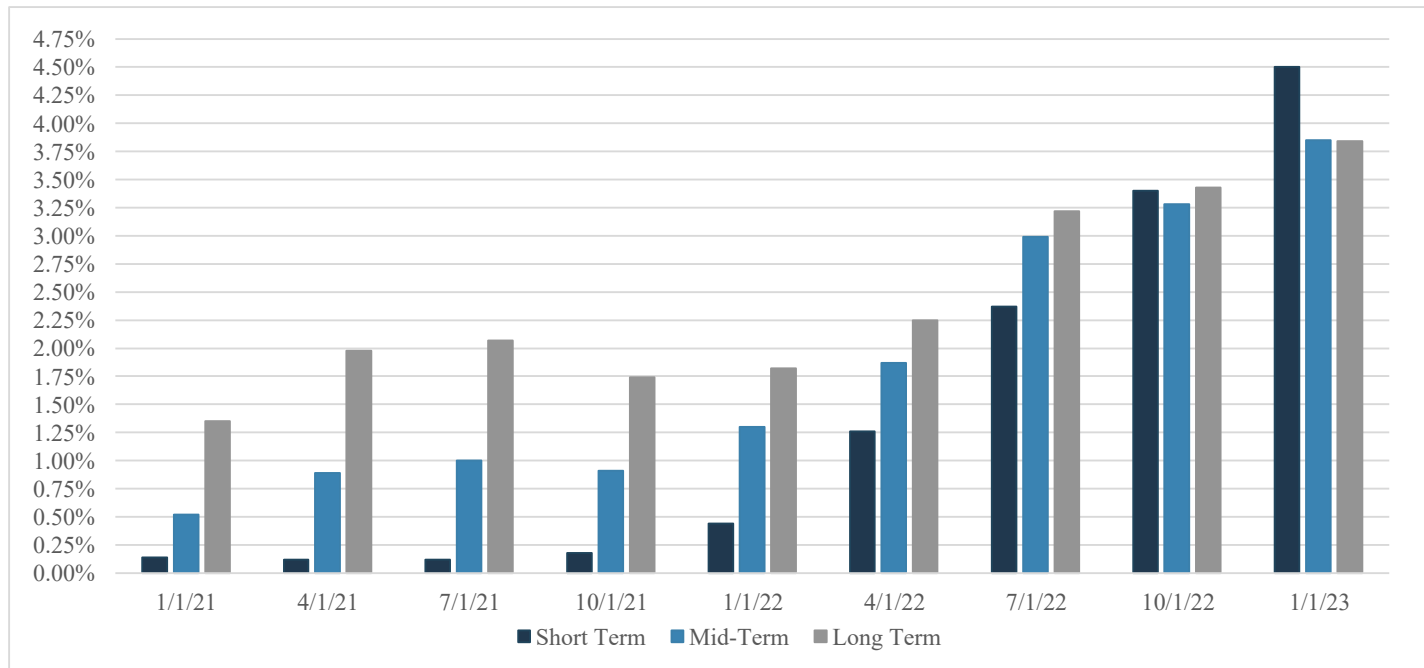

# IRS Applicable Federal Rate (AFR) 24 Month History



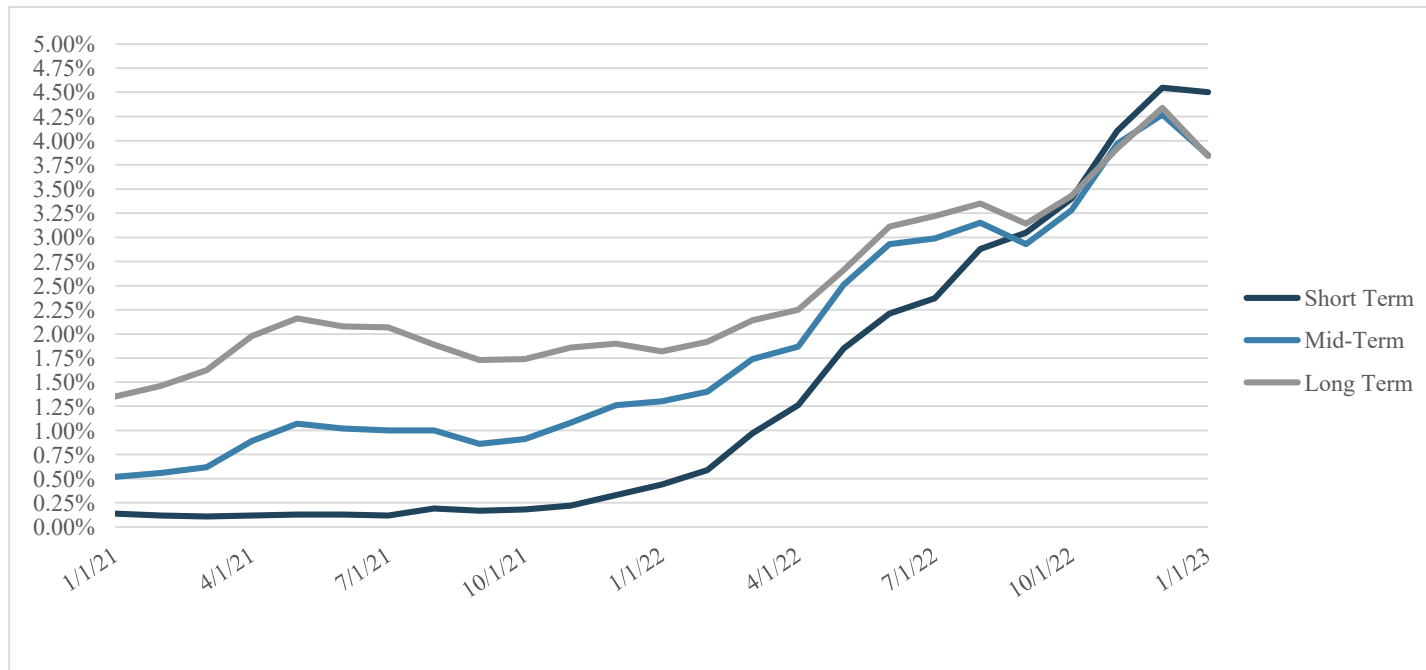
